# **UNIVERSITY DISTRICT**

**Operational four days a week** (Wednesday - Saturday) from 6:00 pm to midnight and 8:00 pm - 2:00 am

**Area covered:** Fifth Avenue on the south, Weber Road on the north, the Conrail tracks on the east, and the Olentangy River on the west (excluding OSU property)

**CPD personnel assigned:** not a permanent position; various 3 & 4 Precinct officers carry our radio for coverage

#### Highlights:

In January, patrollers came across an injured person in front of 1652 N. High; the Columbus Fire Department was notified of the situation. **CFD EMS 7 responded to the scene and treated the person's wounds.** 

In March, patrollers reported an individual causing a disturbance in front of 1350 N. High; CPD was notified of the situation via 645-4545. CPD Car 44 responded to the scene and diffused the situation.

In April, patrollers reported a possibly intoxicated female operating a vehicle in front of 1759 N. High. Patrollers flagged down several Ohio State University Officers. Responding officers arranged for alternative transportation for the female.

In June, patrollers reported a belligerent male in front of 1479 N. High. The patrollers advised that the male was yelling at merchants and throwing traffic cones; CPD was notified of the situation via 645-4545. CPD Cars 40 and R-40 responded to the scene. The male was placed under arrest for possession of illegal drug paraphernalia.

Patrollers also initiated three squad runs, reported five disturbances/fights, and conducted a dozen well-being checks.

# HILLTOP/FRANKLINTON

#### **Highlights:**

In February, patrollers reported a possibly intoxicated female walking in traffic in the area of Broad and Wisconsin. Net Care was notified of the situation; CPD Car 84 and Columbus Fire Department Medic 810 responded to the scene. **CFD Medic 810 transported the female to Mount Carmel Hospital.** Also in February, patrollers were approached by a female in the area of Broad and Dakota who advised that she was sexually assaulted; CPD was notified of the situation via 645-4545. CPD Cars 80, 153, and Columbus Fire Department Medic 10 responded to the scene. **CFD Medic 10 transported the female to Mount Carmel Hospital.** 

In August, patrollers monitored an argument between a male and a female in the area of Wisconsin and Broad; CPD was notified of the situation via 645-4545. CPD Cars 9192 and L-3 responded to the scene. Responding officers diffused the argument, and the female was advised that if she returns to this address, she will be charged with criminal trespassing.

In November, patrollers were approached by a merchant in the area of Dakota and Broad who advised of a criminal trespasser on the property. The patrollers stood by while the merchant advised the trespasser to leave the property. The trespasser left the property as requested. No further action was taken. Later in the evening, the patrollers returned to the business and met with the merchant and CPD Car 82. The trespasser had returned to the premises while the patrollers were out of the area. **CPD Car 82 provided the name of the trespasser to the patrollers and advised that if she is seen on the property again to immediately contact CPD.** 

In December, patrollers witnessed an incident of domestic violence between a male and a female in the area of Broad and Dakota; CPD was notified of the situation via 645-4545. While awaiting the arrival of police, the male left the area. CPD Car 9081 arrived on the scene and spoke with the female at Dakota and Broad. CPD Car R-80 located the male in the area of Rodgers and Broad. The male fled from Car R-80. CPD Car 9081 left the area to assist responding officers in locating the male. A short time later, the male was taken into custody by CPD Cars R-80 and Car 9081. Responding officers all met at Dakota and Broad. The male was charged with obstruction and providing false information.

Patrollers also conducted several well-being checks, reported 3 fights and 6 disturbances/trespassers.

#### Highlights:

In January, patrollers entered a business at 280 E. Whittier and assisted a CPD special duty officer. The officer was arresting a shoplifter. The patrollers acted as witnesses and back up to the officer. **The suspect was placed under arrest for shoplifting.** 

In July, patrollers were approached by a male who requested medical attention in front of 1036 Front; The Columbus Fire Department was notified. CFD Car 3 responded to the scene and transported the male to the hospital.

In August, patrollers were approached by a pedestrian in the area of Gates and Jaeger who advised that **three to four males attempted to rob him in the area**. The pedestrian advised that CPD had already been notified of the situation; patrollers took note of the suspects' descriptions and last known location. A short time later, patrollers met with CPD Car 113 in the area of Moler and High, and discussed the attempted robbery and further details about the suspects involved.

In October, patrollers were approached by a resident in the area of 5th and Jenkins. The resident advised that she found notes about the neighborhood on the ground. The notes outlined security measures that homes in the area were utilizing. The patrollers took note of the situation.

In November, patrollers reported an inoperable vehicle, sitting on bricks, on the roadway in the area of Bruck and Nursery; CPD was notified of the situation via 645-4545. CPD Car 110 responded to the scene. No further action was taken.

Over the course of the year, multiple reports of random gunfire were called in by patrollers.

#### Highlights:
