

# Community Crime Patrol

## UNIVERSITY DISTRICT

- **Operational four days a week** (Wednesday - Saturday) from 7:00 pm to 3:00 am
- **Area covered:** Fifth Avenue on the south, Arcadia Road on the north, the Conrail tracks on the east, and the Olentangy River on the west (excluding OSU property)
- **CPD personnel assigned:** not a permanent position; various 3 & 4 Precinct officers carry our radio for coverage

## HIGHLIGHTS:

On the evening of January 13, 2022, patrollers witnessed a male vomiting in the driver's seat of a parked vehicle in the area of East 11th Avenue and North Fourth Street; CPD was notified of the situation via 645-4545. Columbus Fire Department Medic 7, CFD Engine 7, CPD Cars 7, 40, 43, 44, and 7513 all responded to the scene. **CFD Medic 7 transported the male to The Ohio State University Wexner Medical Center.**

In February, patrollers reported an auto accident involving three vehicles in the area of 15th and Summit; CPD was notified of the situation via 911. The patrollers advised that the suspect vehicle left the area before the arrival of police. CPD Cars 41 and 44 responded to the scene. **Columbus Fire Department Medic 7 responded to the scene. Car 44 took a hit and skip auto accident report.** The patrollers cleared the scene. Later in the evening, one of the patrollers was walking home and witnessed the suspect vehicle driving on High Street. The patroller contacted CPD via 645-4545. It is unknown whether or not CPD was able to stop the suspect vehicle.

In April, parollers heard the sound of an auto accident while in front of 1367 Indianola. The patrollers investigated the situation and located a vehicle on its side. The patrollers advised that a resident had contacted CPD via 911 and advised them of the situation. Columbus Fire Department Engine 7, Columbus Police Department Cars 7, 42, S-4, and R-41 responded to the scene. CPD Car R-41 conducted a field sobriety test on the driver of the vehicle. **The driver failed the sobriety test and was placed under arrest. CPD Cruiser R-41 transported the suspect to the Franklin County Correctional Facility.**

In May, Patrollers reported seeing three shots fired near a large crowd in the area of 13th and Pearl. Patrollers made a quick check of the area for victims and heard four more shots fired. Numerous CPD units responded to the area. The patrollers heard one more shot as they left the area for safety. CPD Car 235 later informed the patrollers that **the shooter had been taken into custody.** The patrollers completed a report.

In July, patrollers reported a domestic dispute in the area of 15th and High; CPD was notified of the situation via 645-4545. OSU Cruisers 34, 32, and 31 responded to the scene. OSU Cruiser 32 detained the male. The male was found to have active warrants. **OSU Car 32 arrested the male for the active warrant.**
